1. What kinds of Special Educational Needs are provided for at Conifers Primary School?	<ul> <li>At Conifers Primary School we provides support for pupils across the 4 areas of need as laid out in the SEN Code of Practice 2014(updated in 2020) : <ul> <li>Communication and interaction – speech and language difficulties, ASD (autistic spectrum difficulties) and Asperger's Syndrome,</li> <li>Cognition and learning - Specific learning difficulties - dyslexia, dyspraxia and Moderate learning difficulties</li> <li>Social, emotional and mental health difficulties – ADHD (attention deficit hyperactivity disorder) and attachment disorder</li> <li>Sensory, medical and physical needs -hearing impairment, vision impairment, sensory processing difficulties</li> </ul> </li> <li>We have a Thrive base that supports children with their emotional well-being.</li> <li>Looked after children are supported through additional interventions to ensure they make good progress. Children's emotional well-being is supported through our ELSA's and through the Thrive base where appropriate. Meetings are held regularly with other professionals and each child has their own PEP (personal education plan) that is regularly monitored.</li> </ul>
2. What are the school's policies for identification and assessment of pupils with SEN?	<ul> <li>Our assessment policy outlines the range of assessments regularly used in school. If, despite interventions, a child is making significantly slower progress than that of their peers starting at the same baseline or the child fails to match their previous rate of progress a child will be placed on the SEN register after discussion with the parents/carers and appropriate agencies.</li> <li>Pupils who are identified as having SEN, have their needs assessed through : <ul> <li>Feedback from teaching staff, teaching assistants and observations;</li> <li>Progress data, year tests, KS1 and KS2 results and baseline testing</li> <li>Assessment, reports and reviews from external agencies</li> </ul> </li> </ul>

What are the school's policies for making provision for children with SEN whether or not they have Education Health and Care Plans? a )How do we evaluate the effectiveness of provision for children with SEN	Start and end of intervention data is analysed and the progress of the children is discussed during Pupil progress meetings each half term. Actions are then planned for the following term. The school is supporting children who may have fallen behind with their learning with 'catch up programmes in small groups. Children with EHC plans are also having additional intervention 1:1
b) What are the arrangements for assessment and reviewing the progress of children with SEN?	<ul> <li>Progress of SEN children will be discussed by the class teacher Inclusion leader, assessment lead and Head teacher during pupil progress meetings held each half term.</li> <li>Use of attainment and progress data for children with SEN as part of whole school tracking of children's progress in terms of Age Related Expectations (ARE) each term</li> <li>Targets on a child's provision map/Personal Progress reviews are reviewed and shared with parents each term.</li> <li>Use of pupil/parents interviews/questionnaires</li> <li>Children under Speech and Language are reviewed by the service.</li> <li>Children holding an EHC Plan will have an annual review, where a representative from all agencies involved with that child will be invited, interim reviews will be held if necessary.</li> </ul>
c) What is our approach to teaching pupils with SEN	<ul> <li>Provision for SEN pupils includes :</li> <li>Quality first teaching, with appropriate differentiation in place;</li> <li>Alternative ways of recording their ideas (ICT, photographs)</li> <li>Extra adult support in classrooms where appropriate;</li> <li>Time limited interventions programmes</li> <li>Personalised provision through adapted resources and interventions.</li> <li>Advice from external agencies</li> </ul>
d) How do we adapt the curriculum and learning environment?	<ul> <li>The school always acts upon advice received from external agencies</li> <li>Instructions broken into small steps</li> <li>Visual prompts</li> <li>positioning of children with hearing and vision difficulties within the classroom and use of aids as recommended;</li> <li>use of laptops</li> </ul>

	<ul> <li>use of coloured overlays</li> <li>use of sensory breaks, sensory cushions, fiddle toys.</li> </ul>
e) What additional support for learning is available for children with SEN?	Each class has a dedicated TA that supports children in lessons and runs interventions for that class. We also have TAs that run specialist interventions for children across all ranges in the school. Where appropriate, resources and equipment are provided to assist children access the curriculum.
f) What activities are available for children with SEN in addition to those available in accordance with the curriculum?	All extra-curricular clubs are available for all our children. Residential trips are offered to all children in Year 4, 5and 6.
g) What support is available for improving the emotional and social development of children with SEN?	<ul> <li>Pupils are well supported by : <ul> <li>An anti-bullying policy with contributions from all members of the school community</li> <li>The PSHE programme of work followed by all classes.</li> <li>Friendship groups</li> <li>Two trained ELSA's. They support children with programmes such as friendship issues, anger management, self-esteem building.</li> <li>Targeted nurture support for individual pupils.</li> <li>Family liaison and mental health support worker</li> <li>Lunch club</li> <li>Nurture group every morning</li> <li>Thrive base</li> <li>Thrive support staff.</li> <li>Referral to CAHMs</li> <li>Referral to the horse course.</li> </ul> </li> </ul>

What is the level of expertise and training of staff in relation to children with SEN and how will specialist expertise be secured?	<ul> <li>TAs trained to deliver a range of effective interventions, First Class Maths, Success at Arithmetic, Learn to Move, 1:1 reading and Little Wandle phonics</li> <li>Individual training re : Speech and Language, ADHD, ASD, Attachment awareness, specific learning difficulties; Team teach</li> <li>Specialist expertise engaged from external services –</li> </ul>

	Educational psychologist, Outreach from local special school, Hearing and Vision support service, Speech and language. Specialist teachers.
6. How is equipment and facilities to support children with SEN secured?	The Inclusion Leader has a small annual budget to purchase equipment for SEN children. The prioritise for this is decided through

We have a parent evening each term to discuss the progress of all children, where targets and provision maps will be shared. Teachers are available before and after school to discuss small concerns. The teacher will feed this back to the Inclusion leader and a meeting can be arranged if needed. If a child is to have an intervention parents will be informed either by the class teacher or the Inclusion leader. For some interventions the TA running the group will offer an opportunity to discuss the

Please get in contact if there are any concerns or questions regarding interventions and how you can support your child.</li> <li>For any child with an EHC Plan, during the Annual Review, the child is invited to attend, choose some music and snacks and share some of their work. Prior to the meeting the children are asked to complete a questionnaire about what they think they are good at, things they like doing and whether they are getting the help they need as well as what they would like to get better at.</li> <li>As part of the Personal Progress review the children are asked what they are good at</li> </ul>
